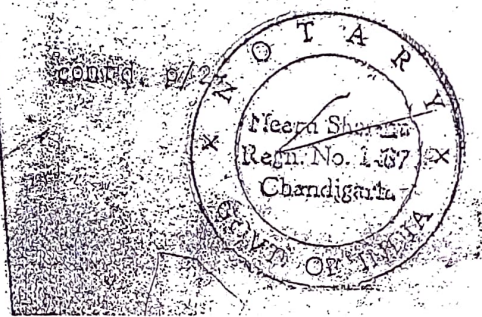
2. After considering the recommendations of DPI Aided (S)

this is also said, in event of non-compliance, then the
No Objection certificate can be taken back immediately.

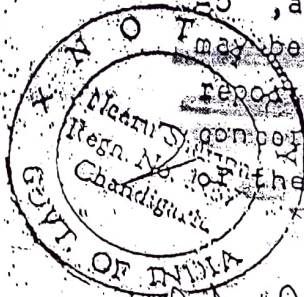
3. The school Management will be bound to give the salaries and other allowances to the Teaching staff and non-Teaching staff like govt. employees after the affiliation with C.B.S.E., otherwise, in case of non-compliance, the No Objection certificate can be taken back immediately.
4. You and your School Management will ensure that as and when the District Education Officer of Your District demands for any information or any other Senior officer of the Education Department demands for information from your school, then the necessary information shall be provided to concerned officer/s and cooperation shall also be given to him.
5. That as per rules, you had to deposit a sum of Rs.3,27,480/- 6 months i.e. equivalent/salary of the staff, in the account of the District Education Officer (SS) Ropar, but you have deposited a sum of Rs.1,50,000/- only, and you deposit the balance payment of Rs.1,77,480/- till one year in the account of the District Education Officer, and intimation may be given to the govt., and in case of non-compliance, No Objection certificate can be taken back immediately.
